We understand the payment terms described above and agree to meet these terms if credit is extended. We agree to pay any late charges assessed as a result of our failure to pay within the stated terms as well as any attorneys' fees, court costs, or other collection expenses arising in connection therewith. Star accepts MasterCard and Visa credit or debit cards on most rental and maintenance transactions, as well as on safety training or testing. Star specifically reserves the right to refuse credit card transactions on lease billings, fuel billings, and on rentals discounted from published rates. It is expressly understood that credit and debit card transactions will be run immediately upon completion of rental or repair. Discounts are based on payment of invoices within terms. Discounts may be eliminated if invoices are not paid within terms.

This Application and any agreements with Star Truck Rentals, Inc. will be construed and enforced in accordance with the laws of the State of Michigan. With respect to any dispute relating to this Application or otherwise involving Star Truck Rentals, Inc. the parties expressly agree to submit to the exclusive jurisdiction of the state and federal courts in Michigan and hereby waive any objections they may now or later have to the jurisdiction of such courts.

This will authorize Star Truck Rentals, Inc. to process via the Automated Clearing House (ACH), at its discretion, any checks presented from our company. This also authorizes Star to process via ACH an additional charge of \$25.00 for any checks returned for insufficient funds and a charge of \$10.00 for any ACH transfer returned for insufficient funds.
